**Instructions:**

1. As per the Constitution of third Bhaskaracharya Student's Association, this year i.e. (2018-2019) the post of **Vice President & Secretary will be amongst the girl students only.**
2. Download the nomination form, code of conduct, constitution of the association and decision of Hon'ble Supreme Court of India regarding Students' Union Election and any other instruction for the conduct during and after the election from University of Delhi official website i.e. www.du.ac.in and the Colleges website http://bcas.du.ac.in respectively for all the post.
3. The nomination should be filed only on this form . Nomination papers filed on any other form/ format shall be considered as invalid.
4. The nomination paper should be filled in, signed and certified in all respect by the candidate himself/ herself, otherwise the nomination form would be considered as invalid. No column should be left blank. No over writing on the application. Incomplete form shall be rejected.
5. The filled up nomination paper along with a Demand Draft of Rs. 500/- from any nationalized Bank in favour of **BCAS Students Fund Account** should be deposited in the sealed box kept in the Conference room (Near Principal office) on all working days (including Saturday) between 10.00 a.m. to 03.00 p.m. but in no case later than 3.00 p.m. on 04<sup>th</sup> September, 2018.
6. **The application form must be duly verified by the Principal.**
7. Withdrawal will be permitted if the application along with College Identity Card is submitted only in writing by the candidate in person. No withdrawal shall be allowed after 12.00 noon on 06<sup>th</sup> September, 2018.
8. Students, who wish to file nominations for more than one post, may do so, subject to the condition that each nomination should be submitted separately with demand draft, required documents and fulfilling all eligibility criterias. However, finally the candidate must withdraw all nominations except for one nomination for which candidate wishes to contest election.
9. **All the supportive documents must be self-attested.**
10. Any discrepancy if found incorrect in the information provided by the candidate as mentioned in the UNDERTAKING AND DECLARATION BY THE CANDIDATE, the nomination would be rejected.
